- Inspire young people to achieve academic growth and excellence
- Provide outdoor recreational opportunities to the area's youth
- Promote skiing as a lifelong activity to be shared with the family
- Allow young people to experience the beauty, freedom and physical challenge of snow sports

Student Requirements:

- Students must be on honor roll (3.0 or higher) or
- Students must show an overall GPA improvement of 0.2 from one grading period to the next.
- Achieve "complete composite National Stanine (NS)" score of 7 or above on his/her 2009 Spring Iowa Test of Basic Skills (ITBS)
- **NEW for 2009-10 – copies of grade reports will NOT be accepted as proof of M-BAR-T qualification, go to moonlightbasin.com to learn how your school will be verifying grades**

Students must comply with the above for their M-BAR-T pass to be active.

Equipment Rentals:

Equipment rentals are provided by Moonlight Basin at a day rate of \$15.00 on a first-come first-serve basis. To receive a rental discount, please present your M-BAR-T pass at MoonRide rentals located at the Madison Base Area. The rentals are subject to availability—during the busiest times of the season, rentals may not be available. There may be a wait time for rentals as part of M-BAR-T.

General Policy & Conditions

Season passes are non-transferable and may not be given, loaned, rented or transferred to anyone for any reason. Any attempt to do so will result in revocation of the pass without refund. In the event a season pass is lost, a new card can be purchased for \$20.00 the 1st time and \$50.00 any time thereafter from the Moonlight Basin Season Pass location. In the event the holder forgets the pass, a ticket can be purchased for \$10.00 each occurrence at the Moonlight Basin Season Pass location. No purchases can be refunded. Passes must be visible when boarding lifts.

Acknowledgement of Risk and Agreement for Waiver, Release, Indemnification and Consent

In consideration for the purchase of a Moonlight Basin Season Pass, and permission to ski/ board Moonlight Basin, the undersigned, on behalf of myself and/or the minor child named below, do hereby agree to the fullest extent permitted by law, as follows:

- 1) I recognize, understand, acknowledge and accept the sport of skiing/ snowboarding (the activity) involves inherent dangers and risks, known, unknown or otherwise, which may cause serious injury or death. I acknowledge that Moonlight Basin does not provide accident, medical, liability, worker’s compensation insurance or any other insurance for activity participants. I accept full responsibility for the foregoing dangers and risks for myself or for the minor child named below.
- 2) Additional RISK ACKNOWLEDGEMENT. Headwaters Lift & Terrain is designated as an expert area only. I understand that in order to access this area, I need to possess the skills and knowledge necessary to navigate this terrain safely. I accept full responsibility for the foregoing dangers and risks for myself or for the minor child named below.
- 3) I agree that I have a duty to participate in a manner that avoids injury to myself and others. I shall comply with the duties of a skier as set forth in MCA 23-2-736 and the rules established by “Your Responsibility Code” which is posted on Moonlight Basin premises and is required to be understood prior to participation in the activity. I acknowledge that Moonlight Basin has the right to revoke activity privileges to anyone who does not comply with Montana statutes or Moonlight Basin Rules.
- 4) I do hereby release, hold harmless and indemnify Moonlight Basin, LLC, Moonlight Basin Ranch, L.P. and its affiliated or parent companies, and their respective employees, agents, officers, members, managers, directors, lenders and insurance carriers (the released parties) from any and all liability for damage, economic loss, personal injury or death to myself and or my minor child resulting from the risks described herein, regardless of whether such risks result from the breach of any expressed or implied warranty, or negligence of Moonlight Basin, LLC, it’s employees, agents, officers, and directors.
- 5) I agree to indemnify and defend each released party from any and all claims of the undersigned or any third party arising in whole or part from the use of the Season Pass or participation in the activity. The undersigned further agrees to pay all costs or attorney fees of any released party incurred as a consequence of my negligence, the negligence of my minor child or arising in any way from violation of the skiers responsibility code by either myself or the minor child named below.
- 6) I authorize any released party and/or their authorized personnel to treat and address medical conditions or emergencies as they deem appropriate. The undersigned further agrees to pay all costs associated with such medical care and related transportation provided for the participant, and shall indemnify and hold harmless the released party for any costs incurred therein, or any claim arising therefrom.
- 7) I grant permission to Moonlight Basin and its authorized representatives rights to the use and reproduction, without compensation, of all photos or visual representations made of the participant in connection with this activity.

If any part of the agreement is deemed unenforceable, the remaining terms shall be an enforceable contract between the parties. This agreement shall be binding upon the assigns, subrogors, successors, heirs, next of kin, executors and personal representatives of the undersigned. I understand this agreement may impact my legal rights, including the right to sue or recover compensation for alleged damages.

I understand that all M-BAR-T passes will be deactivated on or around January 30, 2010 and will not be reactivated until updated grade reports have been presented to Moonlight Basin. Skiing privileges will be revoked by school and/or ski area officials if deemed necessary.
