Each session will be focused on developing technical & tactical skills, terrain/feature knowledge, and athlete safety.

As well as the skills mentioned above the program seeks to provide athletes with opportunities for personal growth within a team environment, coaches will seek to develop their athletes into well rounded individuals that will develop skills that will assist them not only within the program but also in to the future. Athletes will be asked to define season goals in a number of areas, then work with their coaches to develop a pathway to realize them.

Moonlight Basin's terrain truly defines the term "freeriding". Now it's time to take it to the next level and unleash the potential that lies within. Our coaches are well versed in the world of free riding; they live and breathe the sport. One of our goals is to pass this passion on.

Acknowledgement of Risk & Indemnification Agreement
Snowsports Lesson

“Participant” means each Snowsports student listed on this form. The “Undersigned” means each participant, and when a participant is under age 18, it includes such participants’ parent or legal guardian signing on behalf of himself/herself or on behalf of the minor participant. The participant, acting on behalf of him or herself, or as the parent or guardian of a minor child, hereby voluntarily requests to participate, or to have my minor child participate in a Moonlight Basin Snowsports Lesson (the activity).

I agree the sport of skiing/ snowboarding (the activity) involves inherent dangers and risks, known and unknown, which may cause damage, serious injury or death. Risks may include changing weather conditions; snow conditions as they exist or as they may change, including ice, hard pack, powder, packed powder, wind pack, corn snow, crust, slush, cut-up snow, and machine-made snow; avalanches, except on open, designated ski trails; collisions with natural surface or subsurface conditions, such as bare spots, forest growth, rocks, stumps, streambeds, cliffs, trees, and other natural objects; collisions with lift towers, signs, posts, fences, enclosures, hydrants, water pipes, or other artificial structures and their components; variations in steepness or terrain, whether natural or the result of slope design, snowmaking, or snow grooming operations, including but not limited to roads, freestyle terrain, ski jumps, catwalks, and other terrain modifications; collisions with clearly visible or plainly marked equipment, including but not limited to lift equipment, snowmaking equipment, snow grooming equipment, trail maintenance equipment, and snowmobiles, whether or not the equipment is moving; collisions with other skiers; the failure of a skier to ski within that skier's ability; skiing in a closed area or skiing outside the ski areas boundary as designated on the ski area trail maps; and restricted visibility caused by snow, wind, fog, sun, or darkness. **I accept all legal responsibility for injury or damage of any kind to the extent that the injury or damage results from inherent dangers and risks of skiing.**

I agree the use of aerial lifts also involves inherent dangers and risks. I understand that all participants who use aerial lifts shall be presumed to have sufficient ability and physical dexterity or personal assistance to approach, load, ride, unload, depart, and in the event, be evacuated from aerial lifts safely. I am aware that my child may ride aerial lifts alone, or without supervision. **I accept all legal responsibility for injury or damage of any kind to the extent the injury or damage results from inherent dangers and risks of aerial lift use. I accept that my child may be riding aerial lifts alone, or without supervision by an adult or Snowsports instructor.**

I agree I have a duty to participate at all times in a manner that avoids injury to myself and others. I shall comply with the duties of a skier as set forth in Montana Code Annotated 23-2-736 and the rules established by “Your Responsibility Code” endorsed by the National Ski Area Association, which are posted on the ski area’s premises; a complete copy of each is available at the Ticket Sales offices’ at Big Sky Resort and Moonlight Basin. The participant using this pass shall know the range of the participant’s ability and safely ski within the limits of that ability and the participant’s equipment so as to negotiate any section of terrain or ski slope and trail safely and without injury or damage; know that the participant’s ability may vary because of ski slope and trail changes caused by weather, grooming, or participant use; maintain control, speed and course so as to prevent injury to myself and other participants; abide by the requirements of the skier responsibility code that is published by the national ski area association; obey all posted or other warnings and instructions of the ski area operator; read the ski area trail maps and be aware of its content. I acknowledge the ski area operators have the right to revoke activity privileges to anyone who does not comply with Montana statutes or ski area rules.

I agree helmets may reduce or mitigate the severity of head injuries to the participant, but helmet use is in no way a guarantee of safety. The undersigned further recognize that helmets have limited capability as far as shock absorption and that serious injury or death can result from both low and high energy impacts, even when a helmet is worn.

I consent to the use and reproduction, without compensation, of all photos or visual representations made of the participant in connection with the activity.

ON BEHALF OF MYSELF AND THE MINOR CHILD(REN) NAMED ON THIS AGREEMENT, I HEREBY ACKNOWLEDGE AND ACCEPT WITHOUT RESERVATION ALL RISKS ASSOCIATED WITH THE ACTIVITY, INCLUDING THOSE DESCRIBED ABOVE, AND THOSE KNOWN, UNKNOWN, INHERENT OR OTHERWISE. IN ADDITION, TO THE FULLEST EXTENT ALLOWED BY LAW, THE UNDERSIGNED, IN EXCHANGE FOR PERMISSION TO PARTICIPATE IN SNOWSPORTS ACTIVITIES, DOES RELEASE, HOLD HARMLESS AND INDEMNIFY MOONLIGHT BASIN RANCH LIMITED PARTNERSHIP, MOONLIGHT BASIN LLC, AND THEIR AFFILIATED OR PARENT COMPANIES, AND THEIR RESPECTIVE EMPLOYEES, AGENTS, OFFICERS, MEMBERS, MANAGERS, DIRECTORS, LENDERS AND INSURANCE CARRIERS (THE RELEASED PARTIES)

FROM ANY AND ALL LIABILITY FOR DAMAGE, ECONOMIC LOSS, PERSONAL INJURY OR DEATH TO MYSELF AND OR MY MINOR CHILD RESULTING FROM THE RISKS DESCRIBED HEREIN, REGARDLESS OF WHETHER SUCH RISK RESULTS FROM THE BREACH OF ANY EXPRESSED OR IMPLIED WARRANTY.

THE UNDERSIGNED REPRESENT THAT THE PARTICIPANT IS ABLE TO PARTICIPATE IN THE RIGORS OF THE ACTIVITY. THE UNDERSIGNED ACKNOWLEDGES THAT MOONLIGHT BASIN DOES NOT PROVIDE HEALTH INSURANCE COVERAGE FOR ACTIVITY PARTICIPANTS. THE UNDERSIGNED AUTHORIZES ANY RELEASED PARTY AND/OR THEIR AUTHORIZED PERSONNEL TO 1) CALL FOR OR AUTHORIZE A LICENSED PHYSICIAN OR QUALIFIED MEDICAL SERVICE PROVIDER TO PROVIDE MEDICAL CARE FOR THE PARTICIPANT; 2) TO TRANSPORT THE PARTICIPANT TO A MEDICAL FACILITY OR HOSPITAL IF, IN THE OPINION OF SUCH PERSONNEL, MEDICAL ATTENTION IS NEEDED. THE UNDERSIGNED AGREES THAT UPON THE PARTICIPANTS' TRANSPORT TO ANY SUCH MEDICAL FACILITY OR HOSPITAL THE RELEASED PARTY SHALL NOT HAVE ANY RESPONSIBILITY FOR THE PARTICIPANT. FURTHER, THE UNDERSIGNED AGREES TO PAY ALL COSTS ASSOCIATED WITH SUCH MEDICAL CARE AND RELATED TRANSPORTATION AND SHALL INDEMNIFY AND HOLD HARMLESS THE RELEASED PARTIES FOR ANY COSTS INCURRED THEREIN, OR ANY CLAIM ARISING THERE FROM.

THE UNDERSIGNED AGREES THAT ALL CLAIMS FOR INJURY, DEATH OR OTHERWISE, REGARDING ANY ALLEGED INCIDENT SHALL BE GOVERNED BY MONTANA LAW AND EXCLUSIVE JURISDICTION FOR ANY SUCH CLAIMS SHALL BE IN STATE DISTRICT COURT IN MADISON COUNTY, MONTANA, OR IN A FEDERAL DISTRICT COURT IN MONTANA.

THE MINOR PARTICIPANT'S PARENT OR LEGAL GUARDIAN VOLUNTARILY GRANTS PERMISSION FOR THE MINOR PARTICIPANT TO TAKE PART IN THE ACTIVITY AND ACKNOWLEDGES THAT BUT FOR SUCH GRANT OF PERMISSION, THE MINOR PARTICIPANT WOULD NOT BE PERMITTED TO TAKE PART IN THE ACTIVITY.
